Risk: the chance, H, M or L, that somebody will be harmed by the hazard

1. Identify potential hazards, e.g. traffic, lost children, exposure to sun, roads
2. Identify those at risk, juniors, coaches, helpers, parents
3. Where there is a risk, identify a control to reduce risk

| Weather | Extreme hot/cold Weather. | Child | 1 | 2 | 2 | Check the weather forecast, and make appropriate provisions eg. Remove snow, issue sun screen etc | Coaches |
| Medical | Pre existing medical conditions. | Child | 1 | 2 | 2 | Accurate records of medical conditions, emergency contacts etc | Hockey Manager– J/Coaches |
| Personal Injury whilst participating in the activity | Injury through sport. | Child | 1 | 2 | 2 | Ensure children are properly warmed up/warmed down, and aware of health and safety procedures. All Juniors must have correct equipment, including gum shield and shin pads. A ratio of 1 coach/helper: 12 children. | Coaches/ Helpers |
| | Treating injuries. | Child | 1 | 1 | 1 | Ensure there is a first aid kit per group on the pitch. Ensure all coaches have first aid training. | Hockey Manager- J/Coaches |
